**INSTRUCTIONS:**

2. Complete form in its entirety. Failure to complete form in its entirety (specifically narrative section) may cause a delay in the disqualification of the operator.
3. Must be submitted to the DMV **within 48 hours of the arrest.**

Section 14-44(d) of the Connecticut General Statutes (C.G.S.) requires that upon the arrest of any person who holds an operator's license bearing a public passenger endorsement (S, V, A or F) and is charged with a felony or violations of section 53a-73a or 53a-63, the arresting officer or department, within forty-eight hours, shall file a report of such arrest to the Commissioner of Motor Vehicles.

"Public passenger endorsement": means an endorsement issued to an individual, which authorizes such individual to transport passengers, including, but not limited to, passengers who are students in accordance with subsection (b) or (c) of section 14-36a.
