3. If vehicle is not claimed within 48 hours, Police Department must send a copy to the vehicle owner and all lienholders (if any).

INSTRUCTIONS FOR PRIVATE PROPERTY TOW

1. Please type or print clearly.
2. Tower COMPLETE SECTIONS 1, 2, 3, 4 and 6. Tower must notify the Police Department of the tow in writing, or by fax or e-mail, within 2 hours of the tow.
3. If vehicle is not claimed within 48 hours, tower must send a copy to the vehicle owner, all lienholders (if any), and retain a copy.
