RE: **American Rescue Plan Act / Coronavirus State and Local Fiscal Recovery Funds Program - Tranche 2**

The Coronavirus State and Local Fiscal Recovery Funds Program of the American Rescue Plan Act (ARPA) includes three (3) categories of municipalities that will be receiving funds from ARPA through the Local Fiscal Recovery Fund:

- 1) "entitlement units of local government,"
- 2) "non-entitlement units of local government," (NEU) and
- 3) counties.

Under category #1, municipalities will receive funds directly from Treasury. For categories #2 and #3, funds will be received and distributed by the Office of Policy and Management.

A [town-by-town listing](#) is attached of the allocations for the tranche 2 period. Distribution amounts are determined based on the methodology and formula provided by the U.S. Department of Treasury and must be equal to the tranche 1 amount.

A reminder that on April 4, 2022, the unique entity identifier used across the federal government changed from the DUNS Number to the Unique Entity ID (generated by SAM.gov). Existing registered entities can find their Unique Entity ID by following the steps [here](#). This information will be needed for processing your claim.

Municipalities and Boroughs, through their COVID Portal contact, will complete the web-based claim and certification process similar to the tranche 1 process.

NEU and county distribution claims must be submitted no later than **5:00 PM Friday, July 22, 2022**. Portal instructions will be sent separately to each COVID Portal contact.

Once OPM has reviewed and verified the certifications, payment will be processed within thirty (30) days of receipt of funding from U.S. Department of Treasury. Note that separate payments are being made for the NEU and County portions.

Payment Timeline:

- Municipality/Borough Claim Submission due by 5 PM July 22, 2022
- NEU pass through allocation by August 10, 2022
- County pass through allocation within 30 days of Treasury receipt
